Wintergarden Groundwater Conservation District
Board of Directors Meeting
April 16, 2026

The Wintergarden Groundwater Conservation District (the "District") held a Board of Directors Meeting on Thursday, April 16, 2026, at 12:00 p.m. at the District Office, 2881 Hwy. 277, Carrizo Springs, Texas.

1. President Bill Martin called the meeting to order at 12:03 p.m.
2. Directors present were President Martin; Secretary Chris Meyer; Director Martin Kruger; Director Travis Evins; and Director Ed Ritchie. Staff present were General Manager Debbie Farmer and Field Technician Paula VanCleve. Peter Gregg, legal counsel for the District, was present. Visitors present were Diana Nichols, Kelly Hart; Gary and Beverly Box; Corky Weeks; Neal Llewellyn; Norma R. Yeary, MBS Water Well Services; Gene Lindgren, Legacy Water Supply Corporation; Aaron Ward; and Jessica Contreras, Scheduler and Administrative Aide – Dean of the Senate Judith Zaffirini.
3. Gene Lindgren with Legacy Water Supply Corporation presented public comment to state Legacy's opposition of any efforts to reduce the District's recommendation on the Webb County pumping number for Webb County GMA-13 planning (RE: Agenda Items 4 and 5.)
4. Secretary Meyer made a motion to reconsider the recommendation to the GMA-13 associated with the MAG calculations for Webb County as approved by the Board on March 11, 2026. Director Keuger seconded the motion and the motion passed.
5. Director Evins made a motion to reconsider the Board action taken on April 8, 2026 and recommending instead the 20,000 acre-feet per year of production not be included in the GMA-13 GAM Run, and to direct GM Farmer to make this recommendation back to GMA-13. Director Ritchie seconded the motion and the motion passed.
6. Secretary Meyer made a motion to adjourn, and Director Ritchie seconded the motion. President Martin adjourned the meeting at 12:14 p.m.




